Why this campaign?

Let's start with two 'simple' questions: How well are we doing for victims across the EU and does the EU Victims' Rights Directive work in practice?

Our VOCIARE project findings reveal toughest challenges the EU Members States are facing to put the directive in practice. This VOCIARE report from 26 EU countries tracks how EU Member States implement the Victims' Rights Directive 7 years after it was established.

In 2012, the EU Victims' Rights Directive was adopted to ensure that victims across European borders enjoy their rights and have equal access to support services.

Member States were required to transpose the Victims' Directive into their national context and practically implement it to allow victims to exercise rights enshrined in it until 16 November 2015.

However, till now, Member States did not fully establish the adequate procedures and mechanisms for putting the Directive into practice.

None of the Articles of the EU Victims' Rights Directive are fully and satisfactorily implemented for all victims across the EU
 There is no single country that offers full implementation of the entirety of the Directive to all victims on their territory
 There still is a few countries in which there a complete absence of generic victim support services is being registered, while in few more, the support is fragmented and hardly available.

Project VOCIARE aimed at studying the practical implementation of the Victims' Directive at the national level.

During this action week we are going to publicize the main findings of this European-wide research effort.

Ultimately, these findings can stand as a basis for a careful rethinking, at national and EU-level, of how are victims' rights being enacted (or not) and what can be done to improve their standing.

With the #onevoiceonecause campaign we aim to:

Phase 1:

1. Encourage victims to reach out the support services;

2. Inform the audience about the findings of our currently completed 'Project Vociare: Victims of Crime Implementation Analysis of Rights in Europe' in order to continue our practical work on the implementation of the EU Victims' Directive in every Member State.

3. Mobilise people to speak up and take action for victims' rights, as well as show solidarity and support for the victims of crime.



Phase 2:

On 24 June 2020, the European Commission will publish the EU Victims' Strategy 2020-2025. Following the publication of the new EU Victims' Rights Strategy, VSE's communications plan foresees the launch of an information campaign, which will take place in July - November 2020. The campaign aims at explaining how to make the proposed EU Strategy measures work in practice and be effective in order to support the development of victim support services.

The second phase is based on three principles:

1. Listening to the victims, showcasing victims' views and concerns by featuring their testimonies;

2. Explaining how the EU Victims' Strategy affects peoples' everyday lives;

3. Connecting with EU civil society organisations, public authorities and victim support community to address the achievements and provide a mapping of common gaps which indicate the need for improvement in all Member States.

The campaign in practice

Phase 1:

The Action Week **#ONEVOICEONECAUSE** will last from 17th February to 22nd February 2020.

Each of the 6 days of the campaign will cover a specific victims' right to illustrate the law and how it works in practice with different types of victims in society. The campaign also features the findings of the Vociare project from 26 EU countries and showcases the videos in which project partners explain the good practices and the most pressing victims' rights challenges in respective countries. Moreover, Victim Support Europe and its partners have issued the joint statement within the #onevoiceonecause campaign.

Phase 2:

The second phase of the campaign is also conducted in close collaboration with VSE members and partner EU NGOs working for the victims' rights. At this stage, the campaign efforts will be focused around the major upcoming victims' rights related events:

- 7 July: Online Webinar "The EU Victims' Rights Strategy: the future of EU action for victims of crime " led by Didier Reynders, Saskia Bricmont, Levent Altan.

- 22 July: the European Day for Victims of Hate Crime

- 21 August: International Day of Remembrance and Tribute to the Victims of Terrorism

- End of September 2020: the publication of EU Handbook by the European Centre for Victims of Terrorism (EUCVT)

- VSE's November Conference on the safe and strategic use of technologies for victims

Who is conducting the campaign?
